Terry Pope-Recognized a thank you note from Lonnie Evans' family for the bridge naming. He questioned Fire Chief Brian Skidmore on adequate fire protection. Brian answered we are ISO compliant in town both with hydrants locations and with fire trucks carrying water and other agents.

He then commented on a recent meeting of a county delegation with the Governor in which Supervisor Kolb asked for help with completion of the Pennington bypass. Comments ensued on his representation of the town. Council had previously made their opinion known that they believe a bypass would damage town businesses with drivers unable to see the business and the restrictions are that no business can be built along the bypass, leaving any growth to be in the county and not the town. It was again noted Kolb is not Pennington's supervisor and may have misrepresented himself to the Governor in commenting. Greg noted the town needs a subdivision ordinance since land bought for the bypass will soon be available to purchase or return to original owners. Pope noted we will continue our fight against the bypass. He then made a Motion to direct letters to Representatives Kilgore, Pillion and the Governor along with Pennington Supervisors Mosley and Leonard on the towns stance and to send a delegation from Council to meet with the Governor to voice our opposition. Virginia Code Section 2.2-3711(A)(6) Discussion or consideration of the investment of public funds where competition or bargaining is involved, where, if made public initially, the financial interest of the governmental unit would be adversely affected.
