Approximately 356 vacant homes/businesses/lots exist on our system with a meter connection at each. He is proposing a flat rate fee be billed to the owners as several localities are doing. This helps with spreading the cost of maintaining those lines. He will move forward with information to discuss at the budget workshop.

d) Town Manager Report- Keith Harless' report is in the packet. He signed the contract with Quesenberry after they went over a list of recommended cuts to the project. The final contract amount of \$898,600 of which the grant covers \$850k leaving us \$48,600 plus a barrier fence to be decided later in construction. This still saves us \$40k. Keith, Scott Napier and Terry met with reps from USDA, DHCD on how to fund housing. An application will be submitted on April 19 which looks favorable for a \$60k startup. They need to identify properties, where a house existed, for developing homes for low to moderate income workforce applicants who can earn up to \$125k a year with 4 family members.

The hotel site has been surveyed. They will be pinning corners this week.

The VDOT reimbursable entry site will be discussed at a meeting April 18. We need to follow all procurement policies to get reimbursement.

Mattern & Craig policy is in the packet for the civil engineering for hotel, which will meet VDOT requirements, \$124,750. Doug Alsup made a Motion to accept the civil engineering policy. Gary McElyea seconded the Motion. Roll call vote as follows:
